NPGA Central Office

General:

No issues with the Central Office at this time.

NPGA Coordinators:

The Election Coordinator & Show Coordination reports have been received. Both these areas seem to be running smoothly with no issue. As of this writing, the Affiliated Clubs Coordinator report has not yet been received.

Since October I have been performing the duties of the ROA Coordinator. I will submit a separate report for that chair.

Membership Roster

As usual the membership roster will be updated for 2019 in Late February/Early March. All new members receive a roster and a notice in Memo is made to allow any member to request a new roster via email at no charge. Unless the board advises otherwise, if a member requests a CD version of the roster there will be a \$10.00 fee to cover costs.

Registration Certificate show record

It has been brought to my attention that some additions to the show record section of the registration certificate may be necessary. Since we now are allowing 1/3 win for wether champion wins, a section in the record indicating if the show is open or restricted would clarify those wins. This will also be helpful on the doe /buck wins as well. I would like to ask the board to approve the addition of this a column on the back of registration certificates indicating if a show is open or restricted. In addition, addition of a few extra lines on the wether papers may be appropriate as well. In order to accomplish this, I would propose to remove a couple of the transfer of ownership lines. Typically all 6 transfer lines are not required so this would free up the room for the additional show wins.
