#### **COMMUNICATION:**

### **CON-ED POINTS**

Clarification of the point system.

- There are 5 points per year for kids being raised. You can count 4 consecutive years at a time. This would be a total of 20 points if one kid was born in consecutive years.
- 100 points are needed per term. Once the requirements are met, no more points are needed. The points are not to exceed the 100 points or roll over. Once your term has expired then you would need to start submitting points again or attend CON-ED.
