Agenda Item F2: Voted June 13, 2024, Passed #2024-27 15-0  
Membership Dues are due January 1<sup>st</sup> of each year.

The New Membership/Herdbook fee schedule will be as follows:

<b>Youth:</b>	\$25 no Herdbook access(Remains the same)	Due January 1 <sup>st</sup>
<b>Individual:</b>	\$55 includes Herdbook access	Due January 1 <sup>st</sup>
<b>Family:</b>	\$65 includes Herdbook access	Due January 1 <sup>st</sup>
<b>Business:</b>	\$75 includes Herdbook access	Due January 1 <sup>st</sup>

### FEE Payment options:

1. If you only pay Pro-rated fee it pays through 12/31/2024, then new fee is due 1/1/2025  
OR
2. Pay Pro-rated Fees that pays through 12/31/2024 + New 2025 Fees that includes Herdbook beginning 1/1/2025. This will pay dues through 1/1/2026.

INDIVIDUAL:	<b>\$ 8.75</b> + \$55 = \$63.75	Next Due: January 1 <sup>st</sup> , 2026
FAMILY:	<b>\$11.25</b> + \$65 = \$76.25	Next Due: January 1 <sup>st</sup> , 2026
BUSINESS:	<b>\$13.75</b> + \$75 = \$88.75	Next Due: January 1 <sup>st</sup> , 2026
